**Purpose VI** To stimulate the personal and professional growth of members and to encourage their participation in appropriate programs of action

**This award is given to recognize a man or woman who is making an outstanding contribution in any public service arena as a volunteer or as a professional in business, industry or government. The nominee must reside in California, but does not have to be a member of The Delta Kappa Gamma Society International.**

Submit the following by December 1 to the name listed on the nomination form:

1. A nomination form should be obtained from the Chi State Website and completed by the nominating Chapter or individual.

2. Supporting materials for the nomination should be submitted by the member who submits the nomination. Each nomination should be supported by appropriate materials such as letters, news articles, photographs, etc.
3. The nominator must be a member of Chi State who knows the nominee and must submit a letter of recommendation.
4. The endorsers should submit letters of endorsement and do not have to be members of the Society. They may be community members who are knowledgeable of the nominee's contributions.
5. Additional letters of recommendation may be included in the nomination packet.
6. All nomination materials should be submitted together in one nomination packet.
